Re-Certification

If you failed to get any certification CEU's in the first 2 years of the current recertification period you must re-test.

Why? You cannot accrue all of your CEU's in one year nor at one meeting.

Certification Required for Active License

Rule 0080—09-04.05

• (1) Applicants who have passed the license examination(s) must pay all fees within one year of the examination date to obtain the license(s) or be required to re-take the examination(s). Individuals with extenuating circumstances, such as a medical condition or military service, are required to provide documented proof of such circumstances and will be evaluated on a per case basis.



Certification Required for Active License

Rule 0080—09-04.05

• (2) Individuals under expired licenses or certifications must retake the license and certification examinations before they will be eligible to renew the license(s) or certification(s)

Certification Required for Active License

Rule 0080—09-04.05

• (3) All licenses issued under this chapter shall expire upon the expiration of the license holder's certification. Licenses may be reinstated when the license holder recertifies for the certification, provided that the certification has not been expired for more than one year.

- Common mistakes
 - Applicator ID number not listed
 - Target site
 - Use dilution percentage
 - Application rate

Read the label



62-21-103 Business Charter Requirements

- **62-21-103 (c)** reads as follows: (c) All printed advertising shall contain a statement of the charter number of the person on whose behalf the advertising is presented.
- This was deleted by the 2018 amendment.
- (g) All chartered companies are required to label the sides of company vehicles with the name of the company and the charter number. The size of the lettering shall not be less than two inches (2") tall.



Charter Renewals

- Charters A-K are in the process of renewing.
- Current fees are \$400 for charter, \$50 per license
 \$50 for solicitor/technician
- Late Fees will be accessed after January 15, 2019
- Non-chartered individuals are \$50 per license.
